They include psychological phenomena such as emotions, biases, and motivations etc. Psychological therapy and counselling

				<p>studies fall under behavioural research. Emergent design and community-based studies are considered social science and behavioural research unless a clinical intervention is involved. Common methods include, but are not limited to, interviews, focus groups, surveys, questionnaires, behavioural therapy workshops, experimental coaching, observations, and secondary use of data. Behavioural and social sciences studies can be about health and include health care providers and patients, where the goal is not to modify direct patient clinical care (e.g., diagnosis, medication, or treatment). When clinical charts are being accessed for a behavioural study full patient consent is required. Retrospective medical chart review projects should be submitted using the Clinical application form.</p>

It also includes the analysis of laboratory, physiological, kinesiological or biological data obtained from physical interventions, medical records or clinical studies involving the linkage of data from existing databases.
